

| Approval Of Minutes | | On a motion by Kris Culler and seconded by Melanie Furlong, the minutes of the November 17 th meeting were unanimously approved as presented. |

| A. Maximus Dropping Patients From System | <p>A. Mauricio Conde, a Maximus representative, was at the meeting and provided information related to enrollment into the Promise system of HealthChoices. He shared the following salient points:</p> <p>Once a consumer is eligible for MA, they can make a plan selection. Maximus sends them a packet of information including their choices, deadlines, comparison charts, and resources. If they don't hear back from the consumer, a reminder letter is sent and a call is made. If the consumer still doesn't respond, they will be auto-assigned to a plan. However, some people fall through the cracks.</p> <p>Mauricio said they are independent enrollment brokers who are non-biased and don't promote any certain plans or doctors. Their outreach team works with community organizations to provide education to consumers and organizations. They place emphasis on developing community medical homes.</p> <p>Mauricio informed the group of the current 2016 HealthChoices MCOs for physical health: Aetna, Amerihealth, Gateway, United Healthcare, UPMC. The MCOs named for 2017 are: Gateway, Pa Health and Wellness, UPMC, Geisinger Health plan. Mauricio noted that because of the injunction capability that MCOs have the 2017 list of MCOs could be revised and asked that we not notify our clients until a final list has been published which should occur over the next month or two; so, no action should be taken yet. Anyone can make a referral, but complete information is needed.</p> <p>Mauricio distributed an informational packet with contact information for any further questions. It helps them have a stable environment as they are reintegrating into the community from incarceration or drug/alcohol treatment, and connects them to the resources they need. They have a set of rules which must be followed, including holding steady employment and following treatment plans.
